- **Supplementary Panels.** As and when required, the following panels will be convened at short notice, subject to the caveats detailed:
 - **Admissions Panel.**
 - **Composition.** The Panel will consist of 2 Governors and the Head Teacher.
 - **Eligibility.** All Governors will be contacted for availability, should the Panel need to be convened.
 - **Pupil Discipline Panel.**
 - **Composition.** The Panel will consist of 3 or 5 Governors, but it will not include either the Head Teacher or the Staff Governor.
 - **Eligibility.** With the above exceptions, all Governors will be contacted for availability, should the Panel need to be convened.
 - **Complaints Panel.**
 - **Composition.** The Panel will consist of 3 Governors, but it will not include either the Head Teacher or the Staff Governor.
 - **Eligibility.** With the above exceptions, all Governors will be contacted for availability, should the Panel need to be convened.
 - **Dismissal Panel.**
 - **Initial Committee.**
 - **Composition.** The Panel will consist of 4-5 Governors, but it will not include the Head Teacher or the Staff Governor.
 - **Eligibility.** With the above exceptions, all Governors will be contacted for availability, should the Panel need to be convened.
 - **Appeal.**
 - **Composition.** The Panel will consist of 3 Governors, but it will not include the Head Teacher or the Staff Governor.
 - **Eligibility.** Governors on the Initial Committee will be ineligible to sit on the Appeal Committee in the event that it needs to be convened; therefore, with the above exceptions, all other Governors will be contacted for availability.
